C. Roles and Responsibilities

a) Responsibilities of Training Partner:

- I. **Project Manager:** TP would nominate "TP Project Manager" who would act as a single point of contact for the Department of Higher Education for coordination, monitoring, preparing reports, sharing course details to the students and successful implementation of the program.
- II. **Student Orientation:** TP would conduct counselling session, seminars in coordination and support from respective colleges.
- III. **Training Delivery:** TP will ensure that the skill based training is delivered in selected sectors to students enrolling for the program with a view to get them employed in the respective sectors, if they wish to. Following will be ensured by TP and overseen:
  - o Develop content and curriculum for respective job roles and get it delivered through its faculty effectively in the classroom.
  - o Ensure that the entire skill based content designed is delivered in the classroom within the stipulated time. Ensure quality parameters are met.
  - o Ensure conduction of internal assessments of students on a monthly basis as per the assessment pattern set up for the domain.
  - o Conduct soft skills training including preparing the students for work as per the industry requirements.
  - o Inviting and organising guest lecturers from domain related experts working in the industry.
- IV. **Industry involvement:** TP will partner with relevant organisations for deeper involvement into the courses to make these market relevant. Involvement by industry will also help in mapping the market needs.
- V. **Internships and Placements:** TP will facilitate placement of minimum 70% of the students on the successful completion of a course, in case the students so desire.
- VI. **Infrastructure:** TP will use the existing college infrastructure for imparting training.

**Faculty Governance:** The faculty deployed by the TP will work in sync with the time table of the college as desired by the Principal. Functionally they will be under the control of the principal concerned whereas all other matters will be under the TP with overall superintendence / management with the college and the instructions, directions issued by the Principal would prevail.
- VIII. **Service Level Terms:** Following Service Level Terms will be adhered to by the TP:
  - o Complete the syllabus as per the timeline.
  - o Conduct practical classes as per the syllabus wherever applicable.
  - o Conduct work readiness module and prepare students for world of work.

- o Arrange industry guest lectures as and when required.
- o Facilitate industry interaction and interface.
- o Assist / facilitate in placement of the students. 70% placement to be ensured by the TP for the students who wish to be placed or opt for self-employment.
- o Arrange campus interviews wherever possible and needed.
- o Provide all necessary information regarding the project to the college as and when required by it.
- o Provide weekly progress report and attendance report.
- o Participate in review meetings conducted as and when called for.

IX. **Performance Metrics / Measurement:** TP's performance will be measured for:

- o Content delivery as per timeline.
- o Industry engagement.
- o Placement of students, who desire to seek employment (including self-employment).
- o Percentage of students getting certified.
- o Timely and accurate reports.

X. **Leave:**

- o The faculty deployed will be entitled one casual leave per month with the prior approval of the Principal concerned.
- o Maternity leave provisions will be taken care by the TP.

XI. **Penalty Clause:** If any faculty is absent for more than seven working days without intimation or ten working days with intimation (a copy of the leave application should be sent to the Principal concerned), DHE concerned will impose a penalty on concerned TP.

1. Financial implications would be laid out on the TP after 20 days @ Rs 500 per day.
2. A show cause notice would be served on the 21st day to the TP to arrange an alternate Trainer.
3. Post step (2) above the College / NSDC will hear to the concerns of the TP why no replacement / substitution was provided in the school and will take decision accordingly.
4. In case of delay in hiring / substitution in hard and special areas permission needs to be taken from the concerned College / NSDC for extension of time.

XII. **Termination of faculty:** - If any faculty is not found suitable up to the satisfaction of the college up to two months the concerned TP will straight away terminate the services of the said faculty and provide the substitute within ten days.

b) **Responsibilities of DHE and College.** The DHE through its selected college will be responsible for activities such as:

- **Student mobilization:** College will mobilise students for skill courses, workshops, seminars, orientation programs etc.

**The Government Degree College R. S. Pura, Tehsil R. S. Pura-181102, District Jammu, UT of J&K**, through its **Principal, Dr. G. S. Rakwal** (hereinafter, referred as the Party of second part), which expression shall unless excluded by or repugnant to the context be deemed to include its successors-in-interest and assigns, representatives or any other person/s as has been authorized by the Government of Union Territory of Jammu & Kashmir.

**Whereas**, the Central University of Jammu (CUJ) in collaboration with the Department of Higher Education, J&K Government has initiated a joint venture to provide training courses to the eligible and interested candidates/students to form next generation as industry ready students. The primary objective of CUJ is to offer innovative, responsive and high quality educational opportunities to Undergraduate and Post Graduate level students. CUJ is running more than 50 programmes including vocational and skill based programmes. These programmes started by the CUJ to enable the students to seek admission into emerging field of specializations offering challenging job opportunities and career prospects.

**Whereas** with the training of students the CUJ is extended the scope of Student Skill Development, Entrepreneurship Development, Youth Empowerment, Industry Institute Interaction, Digital Empowerment to provide holistic service to every stakeholder of the education ecosystem in developing the next generation of talent pool in India to make them industry ready employees, innovators, entrepreneurs and leaders.

**Central University of Jammu, (CUJ) Rahya-Suchani (Bagla) Samba, Jammu, hereby agrees to enter into this Agreement with The Government Degree College R. S. Pura, Jammu as per the terms and conditions set out hereunder;**

**NOW THIS CONTRACT AGREEMENT WITNESSETH AS UNDER:**

**1. Scope of the Contract Agreement:**

Central University of Jammu, (CUJ) Rahya-Suchani (Bagla) Samba, Jammu, hereby agrees and intended to provide training programs to 30 number of undergraduate students, in



following course/s, in order to enhance competence based training courses in collaboration with the party of the 2<sup>nd</sup> part: the detail of course(s) are as under: .

### 1. Soft Skills and Personality Development

The detail of course with break-up are as under:-

### 2. Role of Central University Jammu:

- 2.1 After getting requisition from the **Principal Government Degree College R. S. Pura** i.e. party of the 2<sup>nd</sup> part, the CUJ/the party of 1<sup>st</sup> party shall get the students enrolled against the courses opted for.
- 2.2 Shall provide the certification to all the students on successful completion of the training.
- 2.3 The party of the 1<sup>st</sup> part shall be responsible for evaluation and certification of learners. The 1<sup>st</sup> Party will provide Certification to successful candidates of Course(s) on **Soft Skills and Personality Development**.
- 2.4 The first party will conduct the training on mutually agreeable terms and conditions as set-forth in the present agreement.
- 2.5. Total training duration is inclusive of internship/assessment and direct teaching in blended mode to be conducted by 1<sup>st</sup> Party.
- 2.6 The party of the 1<sup>st</sup> part shall facilitate lateral entry of NSQF Level 4 certified students who intend to pursue NSQF Level 5 applicable in case of such courses where 1<sup>st</sup> Party is offering courses in relevant trades, for such candidates lateral entry fee as applicable will be charged by the CUJ for admission to NSQF Level 4 course.

### 3. Role of the College:

- 3.1 The second party will release a Course fee upon signing of the agreement, as indicated above for the training which will include the cost of training, registration & evaluation of candidates and award of certificates to the successful candidates.
- 3.2 The payment will be released by the College i.e. party of the 2<sup>nd</sup> Part to Central University of Jammu i.e. the party of 1<sup>st</sup> Part through e-transfer in single installment or 80% of the course fee at the time of signing of the agreement/ commencement of the course and 20% at the time of completion of the course/assessment of course participants.
- 3.3 Shall provide the feedback of Trainers/Resource Persons to 1<sup>st</sup> Party during the course of the program/session. The party of the 2<sup>nd</sup> part shall nominate its Coordinator and will ensure to remain present during the session and shall provide the feedback also.



- 3.4 The party of the 2<sup>nd</sup> party shall provide the infrastructure, fixtures and other consumable goods for the conduct of classes in blended mode in the College.
- 3.5 The party of the 2<sup>nd</sup> part will mobilize minimum batch size of 30 students for conduct of training program.
- 3.6 The 2<sup>nd</sup> Party will ensure attendance of the participants/students and maintain the attendance record on daily basis. The same shall be provided to the Central University of Jammu i.e party of 1<sup>st</sup> Part periodically.
- 3.7 The proposed capacity-building programme shall comprise classroom sessions and self-study sessions to be conducted in blended mode (Online/Offline).
- 3.8 The party of the 2<sup>nd</sup> part shall be responsible for making necessary arrangements for conduct of the course following COVID-19 protocol as per SOPs issued by GOI/UT of J&K from time to time
- 3.9 The party of 2<sup>nd</sup> Part will procure Course-ware (Books and Study Material) both printed and e-copies for Skill Based Programs as recommended by 1<sup>st</sup> Party.

#### **4. Validity of Contract Agreement:**

- 4.1 The validity of this agreement would be 3 years from the date of execution of present agreement. The contract agreement may be renewed on mutually agreed terms and conditions between the parties.
- 4.2 The parties shall have right to terminate the present agreement, if any party does not comply with its obligations under this agreement by issuing 30 days prior notice.

#### **5. Indemnity**

Both, Central University of Jammu, (CUJ) Rahya-Suchani (Bagla) Samba, Jammu, and **Government Degree College R. S. Pura, Jammu** agrees to hold harmless and indemnify from and against all action, demands proceedings, prosecutions, claims or causes of action whatsoever, including (but not limited to) attorneys fees and other costs arising out of:

- (i) Any breach of this agreement by either of the two parties
- (ii) Any negligence on the part of either of the two parties

#### **6. Notices**

All notices regarding this agreement shall be by personal delivery or by certified or registered mail, postage prepaid, at the addresses as either of them may so provide by notice given to the other in the same manner.

#### **7. Governing Law:**

This contract agreement is made under and shall be governed by and construed under the law of Union Territory of Jammu & Kashmir, under the jurisdiction of the Courts at Jammu.



## 8. Arbitration

In the event of any claim, controversy, dispute or difference between the parties, arising out of or in connection with or in relation to this agreement, either party will be entitled to refer the same to arbitration in accordance with the rules of Arbitration and Conciliation Act 1996. There shall be three arbitrators, one to be appointed by the CUJ, the other to be appointed by Government Degree College R. S. Pura and third to be appointed by the two arbitrators appointed by the parties. The award of the arbitrators shall be final and binding on the parties. The Arbitration proceedings shall be held at Jammu.


### Report of Two Vocational Courses held under RUSA

In order to start the add on Courses under Vocationalization of the Higher Education, two vocational courses were sanctioned to our college viz. "Domestic Data Entry Operator and Junior Software Developer" vide letter No. RSPC/1142; dated: 16/09/2017 from Director RUSA, ZumZum Complex Srinagar. For these Courses, a grant of Rs. 3.36 lacs was sanctioned to our college vide Govt. order No. 536 HE of 2017: Dated: 12/09/2017. Sixty students were enrolled for the two courses, thirty for each course. The list of the enrolled students was submitted to the RUSA office vide letter No. RSPC-166: dated: 02/02/2018. An Orientation Programme was held in the College premises on 19<sup>th</sup> January 2018. Mr Khaki Azhar Gull (State Coordinator CSVE (NSQF)) was the resource person in this orientation programme. The said vocational courses were formally inaugurated on 08/02/2018 and the classes for these courses were made functional from 19<sup>th</sup> Feb. 2018 after the allotment of the trainers namely, Ms. Diksha Bhatt and Mr. Rahul Malli. The first installment of training cost amounting to Rs. 1,20,000 (One Lac twenty Thousand) was released on 25<sup>th</sup> April 2018 vide No. RSPC/1699 in favour of Mr. Azhar Khaki, Nodal Officer. The trainer for the second half of the Domestic Data Entry Operator and Junior Software Developer were Ms. Balmeet Kour and Ms. Pooja Rana, respectively. The final examination of Domestic Data Entry Operator was held on 27<sup>th</sup> July 2019 and that of Junior Software Developer was held on 23<sup>rd</sup> July 2019. The placement drive of the enrolled students is postponed by the concerned agency time and again due to the Covid-19 pandemic.


