
The appointees shall report to the concerned Directorate of School Education of respective Division. The concerned Directorates will allow them to join only after verification of the following documents in original:-

- a) Permanent Residence Certificate
- b) Age and Health Certificate
- c) Academic Qualification and Category Certificate (if any) and genuineness thereof.
- d) No Loan Certificate from DIC/concerned District Employment Office.
- e) Character/ antecedents certificates.

If on verification, the certificates produced by the appointee prove to be fake or forged, the appointment shall stand cancelled ab-initio.

The appointment of above candidates shall further be subject to the following conditions:-

- a. 
